I. Call to Order - Pledge of Allegiance

The meeting was called to order at 6:00 p.m. and began with a pledge of allegiance to the flag

II. Review and Approve Agenda

Bob Protivansky made the motion to amend the agenda and add 2651 West Street Trash Ordinance Violation under Additional Items. The motion was seconded by Tom Hogan unanimously approved

III. Lost Trucks

Bill Champine thanked people for attending the meeting and asked each to introduce themselves. Tom Hogan outlined the reason for the meeting by stating this has been a problem for years. He described two incidents that took place last week. We have had enough of it. It is costing us money. He pointed out that Omya is a good neighbor but they have to be a little bit better. We are looking for the thoughts of the other towns. Drivers are following their GPS and ending up on town roads.

Wayne Wilmans noted that many drivers rely on a GPS system and if you goggle Omya you will get the 61 Main Street Proctor address. Omya is trying to correct this problem by using a single Florence address for all Omya activities. When Omya learns of a lost truck they send the dispatcher a letter with the right address. They have tried signs and this has been partially successful. He is open to any suggestion that will help them out.

Dave Potter stated that he doesn't have the answer. It is not a new problem and it is not unique to our towns. He heard testimony on Butch Shaw's GPS bill from the VTrans staff and they felt they wouldn't be able to change the GPS. because they didn't have the proper people to put the information into the GPS system. They didn't think that was the solution and that better signage would help. Maybe we can put all our heads together for better signage. He is here to support the towns.

Amy Gamble distributed a handout and noted that she has been involved with Omya signs for 10 to 12 years. She is here tonight to talk about upgrading signs and is looking for Information on problem roads. Some roads are well posted and some are not. There are not any weight limit signs coming off Route 3 coming into Proctor. The handout shows the signs they propose be installed.; orange State Law sign, white 24,000 weight limit sign and tractor-trailer prohibited symbol sign. The handout also shows recommended locations for signs. The state will pay for signs off state highways. Other signs are the responsibility of the towns.

Discussion regarding why signs noting directions to Omya had to be taken down. These are considered business signs which fall under state sign law statues. Omya and the towns have been trying to work with the state on the directional signs for years.

Discussion regarding the commercial truck GPS system legislation introduce by Peg Flory in the Senate and Butch Shaw in the House. Over whelming support for this legislation by all towns
