### PROGRESS TO DATE:

Lap gas tank was placed by Proctor Gas. After backfilling, they installed all lines to building and generator pad. Generator has been delivered and is being stored in Contractors warehouse. The midstreet valve replacement in North Street will be done on 8/31/16. Stan indicated the inspection of this valve replacement will be performed by Simons Operating Systems, the Towns water system operator. The pump building construction is progressing well.

### **SUBMITTALS:**

No outstanding submittals. Stan Wilbur requested a copy of all approved submittals for the projects records.

### **BOOSTER PUMP DELIVERY SCHEDULE**

The Pump System is currently scheduled for delivery on October 11, 2016. This is the only remaining Critical Path item. This delivery date is beyond the project completion date, and it has been suggested the Contractor request a "time out" period on the contract to allow for an extension of work beyond the required completion date. Otherwise the Contractor will be assessed liquidated damages for time worked beyond the current completion date.

### **OUTSTANDING ITEMS FROM PREVIOUS CONTRACTS**

Some telemetry components remain not connected and not reading into the SCADA system. Specifically, flow meters and line pressure gauges at the East and West tank vaults, and the South Street Vault. Stan Wilbur indicated these items may have been required only in future, similar to the local chlorine injection points at each location. Stan and Dave agreed to review earlier contracts and see if this was the case, or if it was missed during Construction.

**GRADING AT BOOSTER STATION** 

All finish grading is completed. Only loaming and seeding remain. The drainage ditch at the north limit has been installed. Some more stone will be placed for erosion control.

PAYMENT REQUEST NO. 4

A draft of Payment Request No. 4 has been provided to Dave Eves. Tim Herbert needs to provide an updated schedule that will include any shut down period the Contractor wishes to request in recognition of the delayed delivery of the pumps.

MISCELLANEOUS QUESTIONS AND COMMENTS

John Jozwaik requests that construction equipment be stored off-road by the start of school. The cosmetic repair to the "stone wall" on School Street have not taken place yet.
