IV.Committee Operating Policies and Procedures

The function/purpose of the Proctor Town Office Committee is to present a comprehensive proposal to the Proctor community and oversee the renovations of the current Town Office.

V.NBF Preliminary Design Concepts & Cost Estimates – Ed Clark

Ed Clark provided an overview of the four schemes for this project; Scheme 1 & 2 did not fell right for the scale of the building, Scheme 3 included a ramp that was 185 feet long, Scheme 4 includes a lift for access and appears to be the best fit for the building.

Consensus of the committee is Scheme 4 is the best option for the project, it is also the lowest cost of all four options provided.

Scheme 4 includes a lift, re working the stairs, an outside covered ramp, removing ledge downstairs, a 14x12 vault, renovating building to outside wall. The primary work will be on the first floor, with the second floor receiving a face-lift.

Ed Clark will include the front wall in this proposal.

VI.Project Financing

Ed Clark provided Town Manager Stan Wilbur will possible grant options. It was also suggested that Ed Bove of RRPC be contacted for grant options for this project.

VII.Action Items/Responsible Persons

Bill Champine and John Jozwaik will request the funding list from Town Manager Stan Wilbur.

Ed Clark will contact John Jozwiak when he receives the cost estimates for ledge removal and electrical upgrades. Next step, prepare for a community presentation(April), with drawing, cost estimates, grant funding options and seek feedback from community members.
