New Business

Mortimer Proctor Grant Funding - 2025 - grant applications due January 1st. Multiple items can be on each application. Judy explains the logistics of how to apply for grants.

Roller Skating end of season update:

Amanda - switch to ice gear done last week of October. - This took approximately 4 hours of work.

Budget:

Sarah asks: when donations exceed the internet bill, where does the overage go?

Answer: it goes into the Rink general fund

Jeffrey Asks: Can diesel / gas be included in the budget, maybe a gas card?

Discussion regarding how the town handles the garage gas - Judy will follow up on this.

Question regarding preventative maintenance for rink equipment - this is not part of the budget at this time. - Judy will follow up.

Building and grounds improvement:

Issues brought to attention - electrical - issues on the street, this is now fixed. There surges and brown outs happening.

GMP - states that the transformer is undersized for this building - it's two poles up Olympus.

Rink Exterior: Carpenter ants have eaten the wood. Request made to source pest control services.

Rink Deck: Judy reached out to the builder to ask if they can provide quotes on fixing.

Overhead Door Garage: Request to have a company determine if the garage door can be fixed. Judy to follow up.

Skates: many of the roller skates in inventory have wheels meant for indoor use. Outdoor wheels are needed. R4 Soft wheels will wear down faster. In the future more women's skates will be needed.

Question: Pool staff - when will we start looking? The lifeguard course is happening in December.

Answer: The town is already looking - there is another course offered in the spring.

Staff Question: Will there be contracts?

Answer from Judy: Yes
