Action Items

I. Call to Order - Pledge of Allegiance

Lisa Miser called the meeting to order.

The meeting was held in the Town Office Meeting Room; Zoom Video Conferencing was offered as well.

II. Review and Approve Agenda

Bruce Baccei made the motion to approved the agenda as presented.

The motion was seconded by Linda Doty, unanimously approved.

III. Review of Minutes

Albert Wenta made the motion to approve the September 23,2024 regular Selectboard minutes, with corrections. The motion was seconded by Jay Thorton, unanimously approved.

IV. Open Public Comment and/or Good Stuff

Public Comment:

Chris Turner: Shared that he continues to have a water flow issue at his residence on Newton Street. He has a state organization coming on October 24th to assess the pipes in his residence. The Town Manager requested a copy of that report.

Dan Blake: Shared his water concerns for his residence on Newton Street. He noted that he has installed copper pipes in his home. He noted that on Labor Day his fitting blew and his pressure reached 165. He said that he has had low pressure/water flow for about three years.

John Jozwaik: Stated that his comments at the September 23rd meeting were not included in the minutes. Inquired why Pittsford is doing roadside mowing and wanted to know what happened on Williams Street. He also asked for the compression test for paving. (see Town Manager report).

Rob Cathcart DPW explained the Williams Street project.

Good Stuff: Fall Festival was a huge success with an incredible turnout. The fireworks were spectacular. Thank you to Our Yard for their dedication, every year Fall Festival grows with new events.

Congratulation to Maggie McKearin named Little East Offensive Player of the Week.

- Review Bills & Expenditures and Sign Selectboard Orders: The Selectboard reviewed and signed orders totaling: \$615,920.00. Albert Wenta inquired about the Wilk invoice. The Town Manager will follow up with the paving costs and provided a reply.
- Fire Station-Engineers Final Report next steps: GPR scanning of the floor has been scheduled for 10/21/24. This will be completed prior to grout work being done. The engineer anticipates the grout work to be about 3 days at a cost of \$21,884.00.

 provided.

 also suggested that postcard be sent to all residences about the meeting.

- •Sheriff: Report provided in packet.
- •Town Manager: The Town Manager highlighted her report.
 - •Compression testing possible that the resident meant compaction testing. This is not required unless in the bid document and then it is done by a third-party engineering firm.
 - Dump Day − 60 permits / went well
 - •State of Vermont will do striping on Main Street, North Street and Florence Road
 - Attended VLCT Annual Meeting 10/1 and 10/2
 - Met with RCSD to discuss speeding and patrol routes
 - •Tri-Town Path Meeting 10/23 at 6:30 virtual and in person
 - •Asbestos removed at 2651 West Street have until December 2nd to clean the property
 - •Working with Brock & Scott on delinquent property on North Street
 - •Reached out to Wilk about apron at Beaver Pond entrance- town will level with gravel
 - •Shared communications with project manager for South Street project, engineers and contractors. They are to reseed the greenbelt between road and sidewalk. Residents should be mowing once grown in. Also, no permanent easements are needed.

The pad is visible all around the tank, nothing up against the tank, the hill is clean and the DPW has down a good job removing any trees. There is good cover to prevent any slides.
