- Review Bills & Expenditures and Sign Selectboard Orders: The Selectboard reviewed and signed orders totaling: \$463,190.31.
- Waste Water Treatment Facility Upgrades Jeff Lewis, Aldrich & Elliott: Jeff Lewis was present to provide an overview of the WWTF Project and answer questions. The project cost is estimated at \$5.4 million (\$2.4 for upgrades and \$2.0 for sludge removal), with an estimated monthly increase of \$22.00 per sewer user. The evaluation of the WWTF shows that the equipment is 20 + years old, UV system is at end of life, liners need to be replaced and sludge has not been removed for over 20 years. There is grant funding that is being sought and will be shared at the March Town Meeting. Currently, it is expected that the project would qualify for \$117,00.00 in subsidy from engineering and \$750,00.00 for construction. In addition, the project is assumed to be eligible for a 20% pollution control grant. This would leave \$3,265,800.00 to be financed through the CWSRF program for 20 years at 2%, with an annual loan payment of \$200,262.00, which results in a \$22 dollar a month increase when divided by the 760 sewer users. • Finalizing FY26 Budget:
