Rep.Malay, Senator Collamore and Senator Weeks were present to provide a legislative update. Topics shared and discussed;

- Education: H454 passed out of the House to the Senate Ed committee. Do not anticipate any governance change, but rather looking at funding formula. The state will be using the surplus to buy down the tax rate for this coming year. Which will leave a hole for the following year.
- 3 Acre rule: This is an expensive bill hat will undermine property owners and have significant impact on businesses. The xample of the Rutland Fairgrounds was shared and the funds it will take to address this, which could bankrupt the organization.
- Bail Reform: How difficult it is for judges to impose bail in the state of Vermont. Which continues the catch and release cycle.
- Housing: Programs available to provide grant funds/incentives to individuals to repair abandon properties and place back for housing stock.
- Budget Adjustment Act: The BAA has been vetoed twice by the Governor. Primary concern the hotel voucher program.
- Local concerns that the state will take over the appraisal process, lack of confidence in
 the state for this. Disappointed that the funds for roads and bridges are nonexistent.
 State needs to figure out how to charge those driving electric vehicles. The state must
 address the healthcare issue. Disappointed that the state has pushed the healthcare
 costs issue off for yet another year.
