Activities

Perform all monthly WW sampling

Cleaned UV lights

Turned on second blower for more air in lagoons

Saturday storm shut off power to Styles Meadow and Columbian Ave pump stations had to call in Rob & Kyle to help with generator to run pump stations 5/14/22

Heavy rain on Monday cause high alarms at Willow Street, Styles meadow and Park St pump stations had to call A-1 to pump Willow St so it wouldn't overflow took 2 loads

Had to jet storm water on Willow Street so storm water would stop coming up through the manhole

Pumped 5000 gallows of sewer/storm water from Willow Street with two tanks and a pump to WWTF to help lower level in pump station at Willow

Put gas powered pumps in a WWTF from lagoon 1 to lagoon 2 so the plant would not overflow after Saturday and Mondays storms – since Monday we have had over 2-million-gallon discharge from WWTF

We are almost back to normal

Repaired force main from Columbian Ave to Styles Meadow 4" pipe cracked repaired with wrap around the clamp

- \*House Fire on South Street: Thanks to all that worked on fighting the fire and for getting everyone out safely.

- \*Attended Parks & Recreation Meeting: Rink opening for roller skating May 30th Pool opens June 17<sup>th</sup> @1:00 pm. Rotary will be staining the rink building.
