# I. Call to Order - Pledge of Allegiance

This was a Zoom Conferencing meeting, as well as, in person at the Town Office Meeting Room.

A full board was not seated – all motions passed unanimously unless noted.

### II. Review and Approve Agenda

Bruce Baccei made the motion to approve the agenda, with one addition; Otter Creek Watershed.

The motion was seconded by Tom Hogan, unanimously approved

#### **III. Review of Minutes**

Ben Curtis made the motion to approve the December 12,2022 regular meeting minutes, with a correction on page 2, Hogan to Raymond. The motion was seconded by Tom Hogan, unanimously approved.

### **IV. Open Public Comment**

<u>Butch Shaw:</u> Butch Shaw was present to let the Selectboard know that the legislative session begins next week. Also, that he is always available to assist the town, just call.

<u>Doug Perkins:</u> Doug Perkins was present to discuss the Mosquito District – he is chair of the Otter Creek Watershed. He provided an overview of last season's spraying, noting it was well above an average year for mosquitos and spraying. They have received their 5-year permit for spraying, without public comment. FY24 costs will remain the same with FY25 costs increasing due to the data and algorithm. They would like Proctor to become a member of the district, which would be an approximate expense of \$23,000.00 for four years. This amount includes regular spraying and buying into the capital plan for four years. Pro to joining district- Proctor would have votes at the table. Cons to not joining- they could decide not to allow Proctor to continue as is. No changes in the spray policy or markers.
