He is proposing to build two wooden boxes at each of the Beaver Pond Trail to hold four pairs of Yak-Tracks for winter hiking. He would be responsible for all work and fundraising. The Proctor Free Library has also agreed to partner with Mitchell, to check out additional Yak-Tracks. The Selectboard supported the projected and signed his project papers. **John Jozwaik:** Why are we mowing the side of the road with the zero-turn mower? Potholes haven't been filled. Answers to prior meeting questions: The pick-up truck needs to be sold. The loader was down at the salt shed for work.

- West Street fire damage cleanup update: Continuing to look for the asbestos report for the property. If it can't be found an inspector will not to complete an asbestos report prior to clean-up.
